What is this product?

## Туре

The Fund is an Irish collective asset-management vehicle ("ICAV"). The Fund's value is dependent on the performance of the underlying assets and may go up as well as down. Any capital invested in the Fund may be at risk.

## **Objectives and Investment Policy**

#### Investment Objective:

The Fund aims to provide long-term capital growth and seeks to invest in instruments that offer thematic equity exposure.

#### Investment Policy:

The Fund intends to achieve its investment objective by investing in a concentrated (relative to its reference benchmark) portfolio of shares and similar securities of companies worldwide that are enablers or beneficiaries of digital transformations, while promoting environmental, social and governance (ESG) characteristics within the meaning of Article 8 of the European Union's SFDR.

The Fund will invest up to 100% of its assets in equity securities linked to the digital transformation, defined as the integration of digital technology into a company, through utilisation of data and analytics, that results in a fundamental change in how the company operates.

The Fund may invest in shares including common stocks and other transferable securities such as convertible securities, preferred securities, participation notes, convertible preferred securities, warrants and rights or securities similar to shares which are listed or traded on recognised markets worldwide.

The Fund may invest up to 10% of its assets in cash and other funds for ancillary liquidity purposes.

The Fund uses a bottom-up approach focused on investing, under normal circumstances, in companies that are investing in digitally transforming their businesses. At least 80% of underlying investment holdings will have a minimum of 20% revenues related to digital transformation products & services.

The Fund will not invest in: issuers with involvement in specific excluded activities, such as the production of banned or controversial weapons and tobacco; IPOs by companies engaged in expansion of thermal coal production and non-compliance with UNGC principles; issuers with more than 10% of revenue generated from thermal coal power. Please refer to the Fund's supplement for more details on the excluded activities and specific involvement.

The Investment Manager also applies a sustainability framework to evaluate a company's ESG characteristics, incorporating both quantitative and qualitative analysis based on three key themes: Low Carbon Infrastructure, Data Stewardship and Transitioned Tech Disruptors. Please refer to the Supplement for more details on the sustainability framework and excluded activities.

The Fund may also invest in derivatives for hedging and efficient portfolio management purposes.

#### Intended Retail Investor

The Fund is designed for investors seeking capital appreciation and planning to invest for at least 5 years. The Fund may appeal to investors who are looking for a thematic equity investment.

An investment in the Fund is only suitable for investors who are capable of evaluating the risks and merits of such an investment, and who have sufficient resources to bear any loss as the Fund is not guaranteed and they may receive back less than the amount invested. The Fund is designed for use as part of a diversified investment portfolio. Prospective investors should consult with their financial advisor before making an investment

## Term:

The Fund does not have a maturity date.

The PRIIP Manufacturer cannot terminate the Fund unilaterally. The Board of Directors may furthermore decide to liquidate the Fund in certain circumstances set out in the prospectus and articles of incorporation of the Fund.

# What are the risks and what could I get in return?

#### **Risk Indicator**



The summary risk indicator is a guide to the level of risk of this product compared to other products. # What happens if HSBC Investment Funds (Luxembourg) S.A. is unable to pay out?

The Fund's ability to pay out would not be affected by the default of HSBC Investment Funds (Luxembourg) S.A.. The Fund's assets are kept safe by the Depositary and are segregated from the assets of other Funds. This means that the holdings of one Fund are kept separate from the holdings of the other Funds and your investment in the Fund cannot be used to pay the liabilities of any other Fund. There is a potential liability risk for the Depositary if the assets of the Fund are lost. The Depositary is liable in case of its negligent or intentional failure to properly fulfil its obligations.

In the event of a bankruptcy or insolvency of the Depositary or other service provider, investors could experience delays (for example, delays in the processing of subscriptions, conversions and redemption of shares) or other disruptions and there may be a risk of default. The Fund is not covered by an investor compensation or guarantee scheme.

## What are the costs?

#### Cost over time

The tables show the amounts that are taken from your investment to cover different types of costs.
