What is this product?

Type

The Fund is an Irish collective asset-management vehicle ("ICAV"). The Fund's value is dependent on the performance of the underlying assets and may go up as well as down. Any capital invested in the Fund may be at risk.

Objectives and Investment Policy

Investment Objective:

The Fund aims to provide long-term capital growth.

Investment Policy:

In normal market conditions, the Fund will invest at least 90% of its assets in shares (or securities similar to shares) of companies incorporated in the US or those that earn the majority of their revenue from the US.

The Investment Manager identifies stocks which may or may not comprise the S&P 500 Index (USD Net Total Return) and uses a proprietary quantitative investment process to create a portfolio which focuses on risk premia offered by exposure to factors such as value, quality, momentum, low risk and size.

The investment approach is subject to ongoing research regarding the above factors. A portfolio is then created which maximises the exposure to the highest ranked equity securities based on the above factors while minimising the portfolio's risk.

The Fund may hold cash and money market instruments such as bills, commercial paper, and certificates of deposits for ancillary liquidity purposes.

The Fund may invest up to 10% of its assets in other funds, including HSBC funds.

The Fund may invest up to 10% of its assets in total return swaps. However, this exposure is not expected to exceed 5%.

The Fund may also invest in derivatives for efficient portfolio management purposes (such as to manage risk and costs, or to generate additional capital or income).

- The Fund may enter into securities lending transactions for up to 30% of its assets. However, this is not expected to exceed 25%.
- The reference currency of the Fund is USD. The reference currency of this share class is USD.
- Income is reinvested.
- You may sell your investment on most working days.
- The Fund is actively managed and does not track a benchmark.
 The Fund has an internal or external target to a reference benchmark, S&P 500 Net total Return index.

The Investment Advisor will use its discretion to invest in securities not included in the reference benchmark based on active investment management strategies and specific investment opportunities. It is foreseen that a significant percentage of the Fund's investments will be components of the reference benchmark. However, their weightings may deviate materially from those of the reference benchmark.

Intended Retail Investor

Designed for investors seeking capital appreciation and planning to invest for at least 5 years. The Fund may appeal to investors who are looking for a core equity investment with exposure to US equity investments.

The Fund does not have a maturity date.

Risk Indicator

What happens if HSBC Investment Funds (Luxembourg) S.A. is unable to pay out?

The Fund's ability to pay out would not be affected by the default of HSBC Investment Funds (Luxembourg) S.A.. The Fund's assets are kept safe by the Depositary and are segregated from the assets of other Funds. This means that the holdings of one Fund are kept separate from the holdings of the other Funds and your investment in the Fund cannot be used to pay the liabilities of any other Fund. There is a potential liability risk for the Depositary if the assets of the Fund are lost. The Depositary is liable in case of its negligent or intentional failure to properly fulfil its obligations. In the event of a bankruptcy or insolvency of the Depositary or other service provider, investors could experience delays (for example, delays in the processing of subscriptions, conversions and redemption of shares) or other disruptions and there may be a risk of default.
