Investment objective

The Fund aims to provide security of capital, daily liquidity and a return that is similar to Euro money markets while, considering select environmental, social and governance (ESG) criteria. The Fund qualifies under Article 8 of SFDR.



Investment strategy

The Fund is actively managed. The Fund will invest in a diversified portfolio of short-term securities, instruments and obligations, such as: certificates of deposit; medium term, floating rate notes; commercial paper; bankers acceptances; government and corporate bonds, Eurobonds and treasury bills; ABS; and reverse repurchase agreements. These instruments will be short-term securities that mature in 397 days or less. The Fund seeks to identify issuers that are better at addressing ESG risks and exclude issuers: responsible for the production of tobacco; nuclear armaments and other controversial weapons; and that derive more that 10% revenue from certain sectors such as thermal coal extraction. The Fund's investments will, at the time of purchase, have a credit rating of least A-1 or P-1 (or its equivalent) from a recognised credit rating agency. The Fund's liquidity is daily – meaning investors can redeem their investment on any business day. The Fund is classified as a Low Volatility NAV Money Market Fund under the European Union Money Market Fund Regulations. The Fund's primary currency exposure is to Euro. See the Prospectus for a full description of the investment objectives and derivative usage.



Main risks

- The Fund's unit value can go up as well as down, and any capital invested in the Fund may be at risk.
- The Fund's objective may not be achieved in adverse market conditions. During times of very low interest rates, the interest received by the Fund could be less than the costs of operating the Fund.
- Derivatives may be used by the Fund, and these can behave unexpectedly. The pricing and volatility of many derivatives may diverge from strictly reflecting the pricing or volatility of their underlying reference(s), instrument or asset.




