Investment objective

The Fund aims to provide long term capital growth and income by investing in a portfolio of corporate bonds, while promoting environmental, social and governance (ESG) characteristics within the meaning of Article 8 of SFDR. The Fund aims to do this with a higher ESG score than its reference benchmark.

Investment strategy

The Fund is actively managed.


In normal market conditions, the Fund will invest at least 70% of its assets in a combination of investment grade bonds and other similar securities issued by companies in both developed markets and emerging markets, and in asset-backed securities (ABS) and mortgage-backed securities (MBS). With up to a maximum of 20% of its assets in ABS and MBS. Companies and/or issuers considered for inclusion within the Fund's portfolio will be subject to excluded activities in accordance with HSBC Asset Management's Responsible Investment Policies. Please refer to the prospectus for more details on ESG credentials and excluded activities.

The Fund may invest up to 10% in onshore Chinese bonds; up to 10% in non-investment grade rated bonds; up to 10% in convertible bonds; up to 10% in contingent convertible securities; up to 10% in other funds; and may invest in bank deposits and money market instruments. The Fund's primary currency exposure is to USD.

🖄 Main risks


