What is this product?

#### Туре

The Fund is an investment company incorporated as a société anonyme qualifying as a Société d'Investissement à Capital Variable. The Fund's value is dependent on the performance of the underlying assets and may go up as well as down. Any capital invested in the Fund may be at risk.

#### **Objectives and Investment Policy**

#### Investment Objective:

The Fund aims to provide long term capital growth and income with a low correlation to traditional asset classes. The Fund's average volatility is expected to be around 7% over the investment horizon. It may fluctuate due to market conditions and the annualised volatility could be lower or higher than this level.

#### **Investment Policy:**

The Fund targets returns that are less sensitive to market fluctuations and targets an average volatility (fluctuations in the price of a security) of 7%.

The Fund takes 'long' positions (if there is an expectation for assets to rise in value) or 'short' positions (if there is an expectation for assets to fall in value) and uses a range of investment styles (Styles). The Fund invests across a diversified range of asset classes (including equity, fixed income, and currency) on a global basis, including emerging markets.

The Styles employed by the Fund include a carry strategy (which aims to take long positions in higher yielding assets and short positions in lower yielding assets), value strategy (which aims to take long positions in undervalued assets and short positions in overvalued assets) and momentum strategy (which aims to take long positions in assets with higher recent performance and short positions in assets with lower recent performance). The Styles are expected to have low correlation to each other.

The Fund implements the Styles by primarily investing (both long and short positions) in financial derivative instruments including, but not limited to, equity futures, bond futures, interest rate swaps and currency forwards (including non-deliverable forwards). F

Companies and/or issuers considered for inclusion within the Fund's portfolio will be subject to excluded activities in accordance with HSBC Asset Management's Responsible Investment Policies, which may change from time to time. Please refer to the Prospectus for further details on excluded activities.

The Fund may invest in short-term bonds (or similar securities), money-market instruments, bank deposits and cash for treasury purposes. The Fund may invest up to 10% of its assets in other funds, including HSBC funds.

To implement the above strategies, the Fund mostly uses financial derivative instruments. The Fund may use them for hedging, cashflow management and investment purposes. Derivatives may also be embedded in other instruments used by the Fund.

- The Fund may enter into securities lending transactions for up to 29% of its assets. However, this is not expected to exceed 25%.
- The reference currency of the Fund is EUR. The reference currency of this share class is EUR.

The Fund may be suitable for investors with a medium term investment horizon. The Fund is intended for sophisticated investors aiming for an investment that provides exposure to different asset classes that are mainly achieved by using financial derivative instruments that have the potential to reduce liquidity and increase the volatility of returns. The Fund may be suitable for investors looking for a single strategy fund to add to an existing diversified portfolio.

An investment in the Fund is only suitable for investors who are capable of evaluating the risks and merits of such an investment, and who have sufficient resources to bear any loss as the Fund is not guaranteed and they may receive back less than the amount invested. The Fund is designed for use as part of a diversified investment portfolio. Prospective investors should consult with their financial advisor before making an investment.

#### Term:

The Fund does not have a maturity date.

The PRIIP Manufacturer cannot terminate the Fund unilaterally. The Board of Directors may furthermore decide to liquidate the Fund in certain circumstances set out in the prospectus and articles of incorporation of the Fund.

## What are the risks and what could I get in return?

#### **Risk Indicator**

## What happens if HSBC Investment Funds (Luxembourg) S.A. is unable to pay out?

The Fund's ability to pay out would not be affected by the default of HSBC Investment Funds (Luxembourg) S.A.. The Fund's assets are kept safe by the Depositary Bank and are segregated from the assets of other Funds. This means that the holdings of one Fund are kept separate from the holdings of the other Funds and your investment in the Fund cannot be used to pay the liabilities of any other Fund. There is a potential liability risk for the Depositary if the assets of the Fund are lost. The Depositary is liable in case of its negligent or intentional failure to properly fulfil its obligations pursuant to the 2010 Law. In the event of a bankruptcy or insolvency of the Depositary Bank or other service provider, investors could experience delays (for example, delays in the processing of subscriptions, conversions and redemption of shares) or other disruptions and there may be a risk of default. ## What are the costs?

#### Cost over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. - In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.
