Investment objective

The Fund aims to provide long term capital growth and income by investing in a portfolio of corporate bonds, while promoting environmental, social and governance (ESG) characteristics within the meaning of Article 8 of SFDR. The Fund aims to do this with a higher ESG score than its reference benchmark.



Investment strategy

The Fund is actively managed.

In normal market conditions, the Fund will invest at least 70% of its assets in a combination of investment grade bonds and other similar securities issued by companies in both developed markets and emerging markets, and in asset-backed securities (ABS) and mortgage-backed securities (MBS). With up to a maximum of 20% of its assets in ABS and MBS. Companies and/or issuers considered for inclusion within the Fund's portfolio will be subject to excluded activities in accordance with HSBC Asset Management's Responsible Investment Policies. Please refer to the prospectus for more details on ESG credentials and excluded activities The Fund may invest up to 10% in onshore Chinese bonds; up to 10% in non-investment grade


rated bonds; up to 10% in convertible bonds; up to 10% in contingent convertible securities; up to 10% in other funds; and may invest in bank deposits and money market instruments. The Fund's primary currency exposure is to USD.

Main risks

- The Fund's unit value can go up as well as down, and any capital invested in the Fund may be at risk.
- The Fund invests in bonds whose value generally falls when interest rates rise. This risk is typically greater the longer the maturity of a bond investment and the higher its credit quality. The issuers of certain bonds, could become unwilling or unable to make payments on their bonds and default. Bonds that are in default may become hard to sell or worthless.
- The Fund may invest in Emerging Markets, these markets are less established, and often more volatile, than developed markets and involve higher risks, particularly market, liquidity and currency risks.


