## What is this product?

### Type

The Fund is an investment company incorporated as a société anonyme qualifying as a Société d'Investissement à Capital Variable. The Fund's value is dependent on the performance of the underlying assets and may go up as well as down. Any capital invested in the Fund may be at risk.

### Objectives and Investment Policy

#### Investment Objective:

The Fund aims to provide income through investment in a diversified portfolio of fixed income securities and equity securities, money market and cash instruments and other instruments that are related to the USA.

#### Investment Policy:

The Fund will normally invest at least 70% of its assets in bonds (and similar securities) and shares (and similar securities) of companies, money market and cash instruments, and other UCITS eligible asset classes issued by USA related issuers. Exposures will be achieved through investing directly into markets, derivative instruments or investing in other funds.

The Fund may invest up to 100% of its assets in bonds issued by or guaranteed by governments, government agencies or supranational bodies of the USA or by companies which are domiciled in, based in, carry out the larger part of their business activities in, or are listed on a Regulated Market in, the USA.

The Fund may invest up to 70% of its assets in equity securities of companies of any size that are based in, carry out most of their business in, or are listed on a Regulated Market in, the USA.

The Fund may invest up to 30% of its assets in bonds and shares, and up to 10% in commodities, which are not issued by USA related issuers.

Companies and/or issuers considered for inclusion within the Fund's portfolio will be subject to excluded activities in accordance with HSBC Asset Management's Responsible Investment Policies, which may change from time to time. Please refer to the Prospectus for further details on excluded activities.

The Fund will not invest more than 45% of its assets in lower quality debt securities as assigned by market recognised rating agencies, or which are unrated. Asset backed securities (ABS), mortgage backed securities (MBS), convertible securities and contingent convertible securities are excluded from this limit.

The Fund will not invest more than 10% of its assets in lower quality debt securities issued or guaranteed by any single sovereign issuer.

The Fund may invest up to 15% of its assets in low quality ABS and MBS as assigned by market recognised rating agencies, or which are unrated.

The Fund may invest up to 10% of its assets in convertible bonds and contingent convertible securities, up to 30% of its assets in eligible closed-ended Real Estate Investment Trusts, up to 50% in other funds and may invest in bank deposits, money market instruments for treasury purposes.

The Funds currency exposure is to the US Dollar. the Fund may also have exposure to non-US dollar currencies up to 10% of its assets, including Emerging Market currencies.

The Fund may use derivatives for hedging and investment purposes. Derivatives will not be used extensively for investment purposes. Derivatives may be embedded in other instruments used by the Fund.

- ◆ The Fund may enter into securities lending transactions for up to 29% of its assets. However, this is not expected to exceed 25%.
- ◆ Currency hedging is carried out in respect of the share class. The aim is to protect against exchange rate fluctuations between the share class currency AUD and the base currency of the Fund USD.
- ◆ Income is distributed.
- ◆ You may sell your investment on most working days.
- ◆ The Fund is actively managed and is not constrained by a benchmark.

### Intended Retail Investor

The Fund may be suitable for investors with a long term investment horizon and is intended for investors aiming for exposure to asset classes which may be subject to moderately high volatility. The Fund may be suitable for investors looking for an investment to complement an existing core portfolio or as a standalone investment to gain exposure to a specific asset class.

An investment in the Fund is only suitable for investors who are capable of evaluating the risks and merits of such an investment, and who have sufficient resources to bear any loss as the Fund is not guaranteed and they may receive back less than the amount invested. The Fund is designed for use as part of a diversified investment portfolio. Prospective investors should consult with their financial advisor before making an investment.

### Term:

The Fund does not have a maturity date.

The PRIIP Manufacturer cannot terminate the Fund unilaterally. The Board of Directors may furthermore decide to liquidate the Fund in certain circumstances set out in the prospectus and articles of incorporation of the Fund.



## What happens if HSBC Investment Funds (Luxembourg) S.A. is unable to pay out?

The Fund's ability to pay out would not be affected by the default of HSBC Investment Funds (Luxembourg) S.A.. The Fund's assets are kept safe by the Depositary Bank and are segregated from the assets of other Funds. This means that the holdings of one Fund are kept separate from the holdings of the other Funds and your investment in the Fund cannot be used to pay the liabilities of any other Fund. There is a potential liability risk for the Depositary if the assets of the Fund are lost. The Depositary is liable in case of its negligent or intentional failure to properly fulfil its obligations pursuant to the 2010 Law.

In the event of a bankruptcy or insolvency of the Depositary Bank or other service provider, investors could experience delays (for example, delays in the processing of subscriptions, conversions and redemption of shares) or other disruptions and there may be a risk of default. The Fund is not covered by an investor compensation or guarantee scheme.

## What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

### Cost over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- ◆ In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.
- ◆ AUD 10,000 is invested.
