What is this product?

The Fund is an investment company incorporated as a société anonyme qualifying as a Société d'Investissement à Capital Variable. The Fund's value is dependent on the performance of the underlying assets and may go up as well as down. Any capital invested in the Fund may be at risk.

Objectives and Investment Policy

Investment Objective:

The Fund aims to make a positive environmental, social and governance (ESG) effect, by investing in bonds and other similar securities issued by companies/issuers that contribute to United Nations Sustainable Development Goals (Contributing Companies/ Issuers and SDGs), while also aiming to provide long term capital growth and income.

The Fund promotes ESG Characteristics within the meaning of Article 9 of SFDR. More information on HSBC Global Asset Management's responsible investing policies is available at www.assetmanagement.hsbc.com/about-us/responsible-investing.

Investment Policy:

The Fund aims to have a higher ESG score, calculated as a weighted average of the ESG scores given to the companies/issuers in which the sub-fund has invested, than the weighted average of the constituents of the JP Morgan Corporate EMBI Broad Diversified (the "Parent Benchmark").

In normal market conditions, the Fund invests at least 90% of its assets in investment grade and non-investment grade bonds and unrated bonds and other similar securities issued in Contributing Companies/Issuers, that are based in emerging markets. The Fund's investments will be primarily denominated in US Dollar.

The SDGs that the Contributing Companies/Issuers contribute to include: Climate Action, Affordable and Clean Energy, Clean Water and Sanitation, Good Health and Well Being and Reduced Inequalities.

The Fund will also invest in ESG labelled bonds that are aligned with the International Capital Market Association (ICMA) principles, which will not necessarily be issued by Contributing Companies/Issuers. The Fund's ESG metrics is analysed as the fundamental consideration when determining the potential investments. The Fund's investment principles together with sustainability analysis and fundamental qualitative company/ issuer analysis are used to determine the Fund's investments, that include: Engagement with Contributing Companies/Issuers regarding their ESG standards and their ESG standards at various stages of their ESG transition; companies/issuers following good ESG practices (for example, resulting in low and/or decreasing carbon intensity); and labelled securities aligned with ICMA Principles.

Companies and/or Issuers considered for inclusion within the Fund's portfolio will be subject to excluded activities in accordance with HSBC Asset Management's Responsible Investment Policies, which may change from time to time. Please refer to the Prospectus for further details on excluded activities.

Labelled Securities, environmental and social factors, corporate governance practices, lower carbon intensity, excluded activities and the need for ESG due diligence will be identified and analysed using both HSBC's proprietary ESG Materiality Framework and scores as well as research & information provided by financial and non-financial data providers.

The Fund may invest up to 15% of its assets in contingent convertible securities.

The Fund may invest up to 10% of its assets in onshore Chinese bonds, up to 10% in convertible bonds, up to 10% in other funds (which will qualify under Article 9 of SFDR) and may invest in bank deposits and money market instruments for treasury purposes.

The Fund may hold shares (and securities similar to shares) received as a result of or in connection with a corporate action affecting existing portfolio holdings.

The Fund may also invest in derivatives and use them for hedging, cash flow management and efficient portfolio management purposes. Derivatives may also be embedded in other instruments used by the Fund.

- The Fund may enter into securities lending transactions for up to 29% of its assets. However, this is not expected to exceed 25%.
- Currency hedging is carried out in respect of the share class. The aim is to protect against exchange rate fluctuations between the share class currency EUR and the base currency of the Fund USD.
- Income is reinvested.
- You may sell your investment on most working days.
- The Fund is actively managed and does not track a benchmark. The reference benchmark for the Fund is JP Morgan ESG Corporate EMBI Broad Diversified.
- The Investment Advisor will use its discretion to invest in securities not included in the reference benchmark based on active investment management strategies and specific investment opportunities. It is foreseen that a material percentage of the Fund's investments will be components of the reference benchmark. However, their weightings may deviate materially from those of the reference benchmark.

Intended Retail Investor

The Fund may be suitable for investors with a long term investment horizon and is intended for investors aiming for exposure to asset classes which may be subject to moderately high volatility. The Fund may be suitable for investors looking for an investment to complement an existing core portfolio or as a standalone investment to gain exposure to a specific asset class.

An investment in the Fund is only suitable for investors who are capable of evaluating the risks and merits of such an investment, and who have sufficient resources to bear any loss as the Fund is not guaranteed and they may receive back less than the amount invested. The Fund is designed for use as part of a diversified investment portfolio. Prospective investors should consult with their financial advisor before making an investment.

Term:

The Fund does not have a maturity date.

The PRIIP Manufacturer cannot terminate the Fund unilaterally. The Board of Directors may furthermore decide to liquidate the Fund in certain circumstances set out in the prospectus and articles of incorporation of the Fund.

What are the risks and what could I get in return?

Risk Indicator

What happens if HSBC Investment Funds (Luxembourg) S.A. is unable to pay out?

The Fund's ability to pay out would not be affected by the default of HSBC Investment Funds (Luxembourg) S.A.. The Fund's assets are kept safe by the Depositary Bank and are segregated from the assets of other Funds. This means that the holdings of one Fund are kept separate from the holdings of the other Funds and your investment in the Fund cannot be used to pay the liabilities of any other Fund. There is a potential liability risk for the Depositary if the assets of the Fund are lost. The Depositary is liable in case of its negligent or intentional failure to properly fulfil its obligations pursuant to the 2010 Law.

In the event of a bankruptcy or insolvency of the Depositary Bank or other service provider, investors could experience delays (for example, delays in the processing of subscriptions, conversions and redemption of shares) or other disruptions and there may be a risk of default. The Fund is not covered by an investor compensation or guarantee scheme.

What are the costs?

Cost over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. - In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.
