What is this product?

Type

The Fund is an investment company incorporated as a société anonyme qualifying as a Société d'Investissement à Capital Variable. The Fund's value is dependent on the performance of the underlying assets and may go up as well as down. Any capital invested in the Fund may be at risk.

Objectives and Investment Policy

Investment Objective:

The Fund aims to provide long term capital growth and income by investing in a portfolio of emerging market local currency bonds, foreign exchange forwards and other similar securities, while promoting environmental, social and governance (ESG) characteristics. The Fund promotes ESG characteristics within the meaning of Article 8 of SFDR. Investment Policy:

The Fund will normally invest at least 80% of its assets in investment grade and non-investment grade rated bonds, and other similar securities, currency forwards and non-deliverable forwards. These are issued by issuers meeting certain minimum ESG and E, and S and G scores and the consideration of lower carbon intensity criteria .

The Fund invests in bonds issued by governments, government related entities or issuers of emerging markets. Issuers of emerging markets includes issuers based in emerging market countries or issuers from any country, but which carry out the larger part of their business in emerging market countries.

Minimum ESG and E, and S and G scores and lower carbon intensities are based on specific measures such as: electricity produced by renewable energy sources and carbon emissions as provided by the Sustainable Accounting Standards Board; whether the country is on track to meet its Paris Climate Agreement commitments; the level of fiscal transparency a country is considered to have by the Emerging Markets Investors Alliance fiscal transparency reports.

The Fund will invest preferentially in sustainable bonds such as: sustainability-linked bonds, transition bonds, social bonds, and green bonds.

Issuers considered for inclusion within the Fund's portfolio will be subject to excluded activities in accordance with HSBC Asset Management's Responsible Investment Policies, which may change from time to time. Please refer to the Prospectus for further details on excluded activities.

The average maturity of the Fund is normally between 4 and 10 years.

The Fund may invest up to 20% of its assets in Chinese onshore bonds through the China Interbank Bond Market (CIBM), up to 10% of its assets in convertible bonds (excluding contingent convertible bonds), up to 10% in other funds and may invest in bank deposits and money market instruments for treasury purposes.

The Fund may invest up to 10% of its assets in Total Return Swaps.

The Fund mostly invests in emerging market currencies denominated bonds, and it may have exposure up to 10% in bonds denominated in US Dollars and/or other developed market currencies.

The Fund may hold shares (and securities similar to shares) received as a result of or in connection with a corporate action affecting existing portfolio holdings.

The Fund may also invest in derivatives and use them for hedging, efficient portfolio management, tax-advantage access to instruments and return enhancement. Derivatives may also be embedded in other instruments used by the Fund.

- The Fund may enter into securities lending transactions for up to 29% of its assets. However, this is not expected to exceed 25%.
- Currency hedging is carried out in respect of the share class. The aim is to protect against exchange rate fluctuations between the share class currency GBP and the base currency of the Fund USD. However, exchange rate fluctuations between the base currency of the Fund and the currencies of the Fund's assets will not be protected.
- Income is reinvested.
- You may sell your investment on most working days.
- The Fund is actively managed and does not track a benchmark. The Fund has an internal or external target to a reference benchmark, JP Morgan ESG GBI-EM Global Diversified.
- The Investment Advisor will use its discretion to invest in securities not included in the reference benchmark based on active investment management strategies and specific investment opportunities. It is foreseen that a significant percentage of the Fund's investments will be components of the reference benchmark. However, their weightings may deviate materially from those of the reference benchmark.
- The deviation of the Fund's performance and underlying investments' weightings relative to the benchmark are monitored, but not constrained, to a defined range.

Intended Retail Investor

The Fund may be suitable for investors with a long term investment horizon. The Fund is intended for more experienced investors aiming to asset classes that have the potential to reduce liquidity and increase the volatility of return, or investors aiming for very active investment strategies which may result in a concentrated portfolio. The Fund may be suitable for investors looking for an investment to diversify an existing core portfolio.

An investment in the Fund is only suitable for investors who are capable of evaluating the risks and merits of such an investment, and who have sufficient resources to bear any loss as the Fund is not guaranteed and they may receive back less than the amount invested. The Fund is designed for use as part of a diversified investment portfolio. Prospective investors should consult with their financial advisor before making an investment.

Term:

The Fund does not have a maturity date.

The PRIIP Manufacturer cannot terminate the Fund unilaterally. The Board of Directors may furthermore decide to liquidate the Fund in certain circumstances set out in the prospectus and articles of incorporation of the Fund.



What are the risks and what could I get in return?

Risk Indicator

What happens if HSBC Investment Funds (Luxembourg) S.A. is unable to pay out?

The Fund's ability to pay out would not be affected by the default of HSBC Investment Funds (Luxembourg) S.A.. The Fund's assets are kept safe by the Depositary Bank and are segregated from the assets of other Funds. This means that the holdings of one Fund are kept separate from the holdings of the other Funds and your investment in the Fund cannot be used to pay the liabilities of any other Fund. There is a potential liability risk for the Depositary if the assets of the Fund are lost. The Depositary is liable in case of its negligent or intentional failure to properly fulfil its obligations pursuant to the 2010 Law.

In the event of a bankruptcy or insolvency of the Depositary Bank or other service provider, investors could experience delays (for example, delays in the processing of subscriptions, conversions and redemption of shares) or other disruptions and there may be a risk of default. The Fund is not covered by an investor compensation or guarantee scheme.

What are the costs?

Cost over time
